Sri Kanchi Mahaswami Vidya Mandir

Sri Kanchi Mahaswami Vidya Mandir is a unique modern Vedic educational institution at Rajakilpakkam, Chennai. Inspired by the philosophy of His Holiness Pujyasri Chandrasekarendra Saraswathi Mahaswamigal of the venerated Sri Kanchi Kamakoti Peetam, this institution has been established mainly for the promotion of Vedic education.

Located in the culturally vibrant city of Chennai, Sri Kanchi Mahaswami Vidya Mandir was inaugurated by the late Dr. APJ Abdul Kalam on 14th June 2011 and the first lesson was taken by him. He was the first Honorary Teacher of the school. This unique school is the largest vedic -modern education institution in the world which offers the choice of dual education viz Vedic studies + CBSE and CBSE alone.

The vedic school is named after the legendary Dr. L.M. Singhvi and was formally inaugurated by Dr. Murali Manohar Joshi, Member of Parliament on 3rd June, 2012 in the immediate presence of Dr. Abhishek Manu Singhvi, Member of Parliament and members of Dr.L.M.Singhvi's family.

The Vidya Mandir today has 900 students out of which 200 students pursue dual education. Vidyarthi i.e. students who pursue dual education, are to stay full time in the campus i.e. (residential) and for whom all their needs are met by the Vidya Mandir.
